CHRONIC Health Hazards

Carbon Black is classified by IARC as possibly carcinogenic to humans (group 2B) based on experimental animal data, however, there is insufficient evidence in humans for its carcinogenicity.

Prolonged overexposure to solvent ingredients may cause adverse effects to the liver, urinary, blood-forming, cardiovascular, and reproductive systems.

Rats exposed to titanium dioxide dust at 250 mg./m3 developed lung cancer, however, such exposure levels are not attainable in the workplace.

Reports have associated repeated and prolonged overexposure to solvents with permanent brain and nervous system damage.
